Outline of Japan's Non-Project Grant Aid

1. Form of Assistance

- (1) Non-Project Grant Aid (NPGA) is a type of assistance which is intended to support developing countries by promoting its economic and social development efforts including poverty reduction. NPGA has a characteristic of providing foreign currency for import of goods (industrial materials such as petroleum and steel products etc.) necessary to promote economic and social development efforts by the developing countries.
- (2) Further benefits of NPGA can be obtained by utilizing the profits, which should arise from sales or lease of the goods procured under the grant ("Counterpart Fund"), for the recipient country's development projects, in addition to the benefits gained by importing of the goods.

2. Eligible Countries and Scale of the Grant

Eligible countries are, in principle, the countries, which currently implement economic and social development efforts in cooperation with the World Bank and so forth.

The scale of the grant will be determined in consideration of bilateral relations with Japan, and the economic conditions of the country including current account balance, the amount of public external debt, and GNI per capita.

3. Procured Goods

Goods to be procured shall be selected from the "List of Eligible Products", attached to the Agreed Minutes (A/M) to the Exchange of Notes (E/N) concluded between the Government of Japan and the Government of the recipient country. In case the requested goods from the recipient country is not included in the above list, the Government of Japan will examine the request, and if the Government of Japan considers the request appropriate and approves it, the list

4. Eligible Source Countries for the Goods

will be modified to include the requested goods.

All countries and regions except the recipient country are eligible as the source of procurement.

5. Procedures for Implementation

- (1) The government of a recipient country will open an account in a bank of Japan in its name and notify in writing the Government of Japan of the completion of the procedure for opening of the account. Upon notification, the Government of Japan will pay the grant into the account collectively.
- (2) An independent and competent procurement agent will implement the procurement of the goods on behalf of the recipient country. The procurement is, in principle, carried out through international competitive bidding.
- (3) The grant shall be used within one year after its execution (payment into the account in (1) above). However, the period for the use of the grant can be extended by exchange of a Note Verbale, if necessary.
- (4) The government of the recipient country shall report the status of the fund to the government of Japan through the procurement agent.

6. Committee

A Committee is to be held as a place in which to consult between the Government of Japan and the recipient country, in order to enhance transparency and promote effective and prompt utilization of the grant and counterpart fund.

The Committee is composed of the representatives from the recipient country, the Embassy of Japan and the procurement agent, and plays an important role in order to maintain close communication among the related parties in the recipient country.

The Committee is to be held upon request of the members, and the views as to the utilization of the grant, deposit, utilization and publicity of the counterpart fund etc. are widely exchanged.

7. Counterpart Fund

In principle, the government of the recipient country shall deposit at least half of the FOB price of the goods procured under the grant in local currency. Counterpart fund is to be utilized for economic and social development purposes in the recipient country, and specific utilization plan shall be presented to the Embassy of Japan for consultation prior to the utilization.

(NON PAPER) NON-PROJECT GRANT AID FOR PROVISION OF JAPANESE SME'S PRODUCTS (2014)

1. Background

- (1) This grant aid is designed to support the promotion of the economic and social development of developing countries by utilizing the unique efficient and user-friendly technology of Japanese small and medium sized enterprises. These products will meet the development goals of developing countries in several social sectors to respond to the economic and social needs of developing countries.
- (2) The main procedural framework of the aid is based in principle on Non-Project Grant Aid (NPGA), which is intended to support developing countries by promoting its economic and social development through providing foreign currency for import of goods such as industrial machinery necessary to promote economic and social development efforts by the developing countries.

2. Grant Amount

Although the decision cannot be made at this point whether or not Japan can extend the assistance, the grant amount is likely be from 300 million to 500 million Japanese Yen.

3. Eligible Products to be Procured

Goods to be procured shall be selected from the "List of Eligible Products", attached to the Agreed Minutes (A/M) to the Exchange of Notes (E/N) concluded between the Government of Japan and the Government of the recipient country. The products are to be procured through tenders and thus designation of particular manufacturer and its products is not acceptable.

4. End-users

A central government, a local government, an agency thereof, a non-profit organization undertaking a business for public interest, or a non-profit enterprise undertaking a business which can use the products for public interest.

5. Counterpart Fund

Depositing Counterpart Fund is not in principle required, as non-profitable utilization is expected by the End-user (a central government, a local government etc.) under this scheme. However, such measures as requiring deposit of Counterpart Fund should be considered in the event the products are sold in the domestic market of the recipient country.

6. Procurement and Monitoring

A procurement agency should be hired under this grant aid. The procurement agency will procure the products. The developing country should be responsible for appropriate utilization of the Products and its monitoring.

7. Tax

Customs duties and internal taxes, etc. should be exempted when imported.

- 2. Grant Amount

Although the decision cannot be made at this point whether or not Japan can extend the assistance, the grant amount is likely to be from 500 million to one billion Japanese Yen.

3. Eligible Products and Services to be Procured

Goods to be procured shall be selected from the "List of Eligible Products", attached to the Agreed Minutes (A/M) to the Exchange of Notes (E/N) concluded between the Government of Japan and the Government of the recipient country. The products are to be procured through tenders and thus designation of particular manufacturer and its products is not acceptable.

Expected goods to be procured are hybrid vehicle (HV), plug-in hybrid electric vehicle (PHEV), electric vehicle (EV) and clean diesel vehicle (CD). For the application to this grant aid, your government is requested to describe requested goods and its necessary amount on the application form.

4. End-users

A central government, a local government or an agency thereof which can use the products for public interest.

5. Counterpart Fund

Depositing Counterpart Fund is not in principle required, as non-profitable utilization is expected by the End-user (a central government, a local government or an agency etc,) under this scheme. However, such measures as requiring deposit of Counterpart Fund should be considered in the event the products are sold in the domestic market of the recipient country.

6. Procurement and Monitoring

A procurement agency should be hired under this grant aid. The procurement agency will procure the products and Services. The developing country should be responsible for appropriate utilization of the products and its monitoring.
